Executive Summary

1. Introduction

The 2018 Action Plan for the City of Douglas has been prepared in response to a consolidated process developed by the U.S. Department of Housing and Urban Development (HUD) for its formula grant programs.

The City participates in the CDBG program and is required to prepare and submit an action plan for HUD approval in order to receive Community Development Grant Funds.

This Annual Action Plan serves as an application for federal funds under HUD's formula grant programs and provides a basis for assessing performance.

This section constitutes the 2018 Annual Action Plan of the Five-Year Consolidated Plan. It sets forth a description of activities for the use of funds that are expected to become available during the coming Federal fiscal year, determines goals for individuals and households to be served, and describes the implementation plan and geographic location of the activities to be undertaken. The formula allocation for the Community Development Block Grant program is \$158,924.

2. Summarize the objectives and outcomes identified in the Plan

The needs in the City are numerous and varied. The principal needs are: 1) public improvements to improve/revitalize neighborhoods, 2) housing rehabilitation for both owner and renter units, 3) assisting the homeless, 4) assistance for extremely low-income households threatened with homelessness, and 5) programs for youth and the elderly.

Fiscal years 2014/2015 and 2015/2016 funding was targeted towards Public Improvements and Infrastructure, which included curbing, sidewalks and pavement replacement in several low income areas of the community. Based on this, significant improvements have been made in the quality of life to distressed neighborhoods. Fiscal year 2016/2017 funding focuses on owner occupied housing rehabilitation, emergency home repairs and rental assistance programs. Fiscal year 2017/18 focuses on the replacement of outdated playground equipment in the City's largest and most-utilized park.

Proposed activities for FY2018/2019 include the acquisition and/or rehabilitation of a building located within Census Tract 8 or 9 of Douglas City limits, for the purpose of establishing a Community Center to serve the needs of our youth, elderly and all other underserved populations. The Community Center will offer programs and activities for the community's youth and elderly residents to take advantage of, as well as a computer lab and exercise room that will be available for use by any of its residents during regular operating hours.

3. Evaluation of past performance

This is an evaluation of past performance that helped lead the grantee to choose its goals or projects.

For the 2014 program year, the City received Community Development Block Grant (CDBG) funds in the amount of \$191,598.00. For 2015, the City received \$180,622.00. Fiscal year 2014 and 2015 funding was targeted towards infrastructure projects, specifically, curbing, sidewalk and pavement replacement/reconstruction in low mod areas designated in the Consolidated Plan. For 2016, the City received \$165,853 and has targeted those funds for home rehabilitation and emergency housing assistance.

The City is currently working from its most recent five-year strategic planning document, which outlines needs and projects for primarily the low- and moderate-income persons in the City. In previous program years, the City implemented the programs outlined in the Consolidated Plan. The activities/projects addressed infrastructure and public facilities activities for low and moderate-income households.

The City feels that it is imperative that the focus remains on the public facility and infrastructure aspects of the plan. The City continues to believe that meeting these basic needs will help build a strong, safe, and healthy community that will, hopefully, encourage a variety of economic opportunities and contribute to an enhanced quality of life for the residents, particularly the low and moderate-income residents.

The City has completed implementing its 2014 and 2015 goals and objectives. 2014 and 2015 goals and objectives consist of infrastructure improvements to include 6,240 linear feet of curbing, sidewalk and pavement replacement in low-mod neighborhoods.

The City is now focused on completing FY 2016/2017 and FY 2017/2018 goals and objectives and has implemented the administration functions required, such as implementing its Consolidated Plan document, and holding public hearings to determine projects to be completed, seeking public input, etc.

The Infrastructure improvements for both FY 2014 and FY 2015 projects are complete. The City intends to draw down the remainder of the project administration funds for FY2015 in order to close out the year. The City is now focusing on implementing the proposed use of funds for FY 2016/2017 and FY2017/2018. FY2016/2017 goals and objectives consist of Housing Rehabilitation , Emergency Home Repair and temporary/emergency rental assistance to approximately 5 families for a period of three months. FY2017/2018 goals and objectives consist of removal and replacement of old, outdated playground equipment in the City's largest park with new, safe and ADA compliant playground equipment.

During this Five-year Consolidated Plan period, the City is developing greater coordination between all active agencies in Douglas in an effort to minimize any duplication of efforts. Efforts to enhance coordination between the public and private sector will ensure that needs are being properly addressed and that resources are being maximized.

As needed, the Housing Department will provide technical assistance and information to private and public organizations that seek to provide affordable housing and support services to residents of Douglas.

The City of Douglas, through its Public Housing Authority (PHA), offers Section 8 Housing Choice Vouchers to low income residents. Priority is given to extremely and very low income residents. In addition, preferences are offered to Veterans, Elderly/Disabled, Working Families, Residency and Victims of Domestic Violence.

The Cochise County Housing Authority (CCHA), through collaboration with the Veterans Administration, administers a Veterans Administration Supportive Housing (VASH) program, which is targeted to assist homeless veterans throughout Cochise County.

There are currently 11 affordable housing apartment complexes located within the city limits of Douglas.

The PHA also works in collaboration with the Catholic Community Services, "House of Hope" Domestic Violence Crisis Shelter, by offering a preference on the Section 8 waiting list to women and their children who have been victims of domestic violence.

The City participates in the Balance of State Continuum of Care Meetings that the Arizona Department of Housing hosts on a quarterly basis. Efforts are being made to further build contacts and relationships with local, county, and regional entities to support and implement CDBG programs.

The City considers the involvement of its low- and moderate-income residents and those agencies that serve the low- and moderate-income residents to be essential to the development and implementation of its Annual Action Plans.

Publicized public hearings were held on two occasions – on July 25, 2018 and on August 8, 2018. These sessions were part of a concerted effort to obtain as much public input as possible in the preparation of the Plan. The draft plan was made available for public review and comment on the City website and made available in hard copy at the City offices and in the City library between July 25, 2018 and August 8, 2018. The Annual Action Plan was submitted to the City Council for approval at a regularly scheduled meeting on August 8, 2018.

The City of Douglas has identified Census Tracts 8 and 9 as low/mod Census Tracts, and historically, these areas serve a vast majority of the city's low to moderate-income residents.

The City ensures that all Public Hearings are held at times and locations convenient to potential and actual beneficiaries and with accommodations for persons with disabilities. Upon request, in advance of the meeting, the City will attempt to make accommodations for those individuals in need of special assistance. The City also provides technical assistance workshops for all interested in the programs.

The City has identified the building space that will be utilized to serve as the community center and has secured funding for the purchase of the building; however, there are a couple of other very viable options that the City has targeted. Dialogue and discussion has been established with the appropriate agencies and/or individuals in the hopes of acquiring/receiving a location that will be suitable for this project.

Discussion

The City still has CDBG funds left that were allocated for FY 2016 and FY 2017; however, those funds have been allocated for homeowner rehabilitation and emergency housing assistance and the replacement of playground equipment at one of our city parks, respectively. The City intends to expend all allocated funds towards the intended projects and does not expect to have available remainder funds for use towards FY 2018 activities.

FY 2018/2019 funding will be allocated towards the establishment of a Community Center for use by the City of Douglas residents, primarily focusing on programs for the City's youth and elderly population.

The activities were prioritized as part of the Consolidated Plan process, in which public meetings were held, and public needs assessments were conducted. The highest priority needs were determined to be Public Improvements and Infrastructure, Rental assistance, Homeowner Repair, Homeless Assistance and Prevention, Rental Rehabilitation and Community Services for the youth and elderly. The first two fiscal years of the Consolidated Plan focused on Public Improvements. The third year focus was on Owner Occupied Housing Rehabilitation, Emergency Home Repairs and Emergency Rental Assistance programs. Year four targeted the City's focus on Public improvements/public facilities. The fifth and final year of the entitlement will focus on Community Services, primarily focusing on programs for the community's youth and elderly population.

The obstacles the City has encountered with these programs in the past is not having sufficient resources to invest in these programs to provide services for an underserved population.

The City of Douglas has the capacity to oversee the acquisition and/or rehabilitation of an existing structure to convert it to a community center. The City intends on utilizing staff and resources from the Leisure Services and Public Works departments, as well as inmate labor.

The City will concentrate on completing its FY 2016 and 2017 activities which consist of emergency home repair and rental assistance programs and the removal and replacement of playground equipment at the City's largest park, while continuing to build collaboration opportunities with local social service agencies, towards meeting the goals established in the Consolidated Plan, through its Citizen Participation Process. By working together, the City can continue to reinforce those programs, which benefit low and very low income residents.

Actions planned to address obstacles to meeting underserved needs

The greatest challenge to meeting underserved needs in the coming year will be meeting the increased need for program activities with a limited amount of funding. To overcome this significant challenge, the City will work more efficiently, seek a greater level of collaboration with other agencies and organizations, and aggressively seek opportunities to leverage funds.

Actions planned to foster and maintain affordable housing

The City will continue to operate its Section 8 Housing Choice Voucher program. We will continue to seek other funding sources, such as HOME, State Housing Fund, for housing rehabilitation programs. There continues to be a great need for these programs in the community, and funding sources are scarce.

Actions planned to reduce lead-based paint hazards

The City will incorporate all HUD requirements concerning lead-based paint abatement into its housing rehabilitation programs, will see that program participants are informed about lead-based paint hazards and will see that all abatement work is undertaken by qualified contractors who have completed US HUD and EPA lead training courses.

Actions planned to reduce the number of poverty-level families

Because the nature of poverty is complex and multi-faceted, the City will attempt to allocate CDBG funds for services to very low-income households. CDBG can provide funding for meeting these critical basic needs, but these efforts will be constrained by the amount of funds available and competing priority needs.

Actions planned to develop institutional structure

The City will seek partners in the development of a service delivery system and will seek to enhance the

relationship with existing partners in City departments and social service agencies to coordinate the delivery of programs and services. Also the city will seek opportunities to leverage the limited available resources.

Actions planned to enhance coordination between public and private housing and social service agencies

The City maintains a close relationship with state, regional, and county organizations that provide assistance to low- and moderate-income persons as well as the homeless.

The City will work closely with local non-profit organizations to actively encourage housing programs for low- and moderate-income persons. Also, the Housing Department will develop and maintain a positive relationship with the builders, developers, and financial institutions in the region. This collaborative approach will assist in the creation and delivery of effective service delivery programs and affordable housing projects.
