**Case: Douglas General Plan Update 2024**

**Summary Notes to Changes Made from 60-Day Comment Period**

Thank you for the review comments we received between February 9, 2024 and April 9, 2024. The City received a total of 4 formal comments ranging from minor edits, compliments on the plan to a full document with redlines and comments from the public. Below is an abbreviated summary of the highlights of the changes made from those comments. A full redline of the track changes is available for review with this summary as well.
